THE COLD WAR, WITH ITS IDEOLOGICAL STRUGGLE, PROXY WARS, AND THE DEVELOPMENT OF AMERICAN FOREIGN POLICY DOCTRINES, IS ANOTHER MAJOR AREA FREQUENTLY TESTED IN THE INTERNATIONAL CONTEXT.

INCORRECT OPTIONS, STUDENTS SHOULD ANALYZE WHAT MAKES THEM WRONG – IS IT AN INACCURATE HISTORICAL CLAIM, A MISINTERPRETATION OF THE STIMULUS, OR A MISUNDERSTANDING OF THE HISTORICAL PERIOD?

FURTHERMORE, AFTER REVIEWING THE ANSWERS, STUDENTS SHOULD TAKE TIME TO ANALYZE THE CONCEPTS AND HISTORICAL EVENTS TESTED. IF A QUESTION ABOUT THE MONROE DOCTRINE IS CHALLENGING, IT'S AN OPPORTUNITY TO REVISIT THAT TOPIC IN THEIR TEXTBOOK OR REVIEW MATERIALS. CREATING FLASHCARDS FOR KEY TERMS, DATES, OR FOREIGN POLICY DOCTRINES ENCOUNTERED IN THE 2018 INTERNATIONAL PRACTICE EXAM MCQS CAN ALSO BE AN EFFECTIVE STRATEGY FOR REINFORCING LEARNING. KEEPING A LOG OF TOPICS OR QUESTION TYPES THAT CONSISTENTLY CAUSE DIFFICULTY CAN HELP STUDENTS FOCUS THEIR SUBSEQUENT STUDY EFFORTS.

IDENTIFYING WEAKNESSES AND TARGETED REVIEW

ONCE THESE WEAKNESSES ARE IDENTIFIED, STUDENTS CAN ENGAGE IN TARGETED REVIEW. THIS MIGHT INVOLVE REREADING RELEVANT TEXTBOOK CHAPTERS, CONSULTING APUSH REVIEW BOOKS, WATCHING EDUCATIONAL VIDEOS, OR EVEN FORMING STUDY GROUPS TO DISCUSS CHALLENGING TOPICS. BY ACTIVELY SEEKING OUT THESE CONNECTIONS, STUDENTS CAN MOVE BEYOND ROTE MEMORIZATION AND DEVELOP A DEEPER ANALYTICAL UNDERSTANDING. FOR INSTANCE, UNDERSTANDING THE ROOTS OF AMERICAN INTERVENTIONISM IN THE EARLY 20TH CENTURY PROVIDES CONTEXT FOR LATER COLD WAR POLICIES. SIMILARLY, EXAMINING THE ECONOMIC MOTIVATIONS BEHIND 19TH-CENTURY EXPANSION CAN SHED LIGHT ON LATER TRADE POLICIES. THE 2018 INTERNATIONAL PRACTICE EXAM MCQS CAN SERVE AS EXCELLENT SPRINGBOARDS FOR THESE KINDS OF CONCEPTUAL LINKS.

UTILIZING ANSWER EXPLANATIONS EFFECTIVELY

STUDENTS SHOULD APPROACH THESE EXPLANATIONS WITH A CRITICAL AND INQUISITIVE MINDSET. DO THEY UNDERSTAND THE REASONING PROVIDED? IF NOT, THEY SHOULD SEEK FURTHER CLARIFICATION. USING THE EXPLANATIONS TO IDENTIFY SPECIFIC VOCABULARY OR HISTORICAL TERMS THAT NEED FURTHER DEFINITION IS ALSO RECOMMENDED. THE GOAL IS NOT JUST TO MEMORIZE THE CORRECT ANSWER FOR A PARTICULAR QUESTION, BUT TO UNDERSTAND THE UNDERLYING HISTORICAL PRINCIPLES AND ANALYTICAL PROCESSES THAT LEAD TO THAT ANSWER, ENSURING THEY CAN APPLY SIMILAR REASONING TO NEW QUESTIONS ON THE ACTUAL APUSH EXAM.

SIMULATING EXAM CONDITIONS

THE PROGRESSIVE ERA (ROUGHLY 1890S-1920S) SAW SIGNIFICANT SOCIAL AND POLITICAL REFORMS. WHAT TYPE OF QUESTION MIGHT APPEAR ON A 2018 APUSH EXAM REGARDING THIS PERIOD?

A QUESTION MIGHT ASK ABOUT THE GOALS OF PROGRESSIVE REFORMERS, SUCH AS TRUST-BUSTING, IMPROVING WORKING CONDITIONS, OR EXPANDING DEMOCRACY THROUGH INITIATIVES LIKE THE INITIATIVE, REFERENDUM, AND RECALL.

WHICH LANDMARK PIECE OF LEGISLATION FROM THE CIVIL RIGHTS MOVEMENT, LIKELY A FOCUS IN 2018 APUSH MCQS, OUTLAWED SEGREGATION IN PUBLIC PLACES?

THE CIVIL RIGHTS ACT OF 1964 PROHIBITED DISCRIMINATION BASED ON RACE, COLOR, RELIGION, SEX, OR NATIONAL ORIGIN, EFFECTIVELY ENDING SEGREGATION IN PUBLIC ACCOMMODATIONS.
