BACKGROUND AND CAUSES OF THE CUBAN MISSILE CRISIS

THE U.S. HAD PREVIOUSLY STATIONED MISSILES IN TURKEY AND ITALY, THREATENING SOVIET SECURITY, PROMPTING THE USSR TO RESPOND WITH MISSILE DEPLOYMENT IN THE WESTERN HEMISPHERE. THE DISCOVERY OF THESE MISSILES BY U.S. RECONNAISSANCE INTENSIFIED EXISTING TENSIONS AND SET THE STAGE FOR A POTENTIAL NUCLEAR CONFRONTATION.

POLITICAL AND MILITARY TENSIONS BETWEEN THE SUPERPOWERS

DURING THE EARLY 1960S, THE COLD WAR ESCALATED THROUGH ARMS RACES AND PROXY CONFLICTS. BOTH THE U.S. AND USSR SOUGHT TO DEMONSTRATE MILITARY AND IDEOLOGICAL SUPERIORITY, LEADING TO INCREASED SUSPICION AND HOSTILITY. THE CUBAN MISSILE CRISIS WAS A DIRECT RESULT OF THIS COMPETITION, AS EACH SIDE AIMED TO SECURE STRATEGIC ADVANTAGES AND PROTECT NATIONAL INTERESTS.

THE ROLE OF CUBA IN COLD WAR DYNAMICS

CUBA, UNDER FIDEL CASTRO, ALIGNED ITSELF WITH THE SOVIET UNION AFTER THE CUBAN REVOLUTION IN 1959, BECOMING A COMMUNIST STATE IN THE WESTERN HEMISPHERE. KEY FIGURES AND THEIR ROLES

JOHN F. KENNEDY

AS THE PRESIDENT OF THE UNITED STATES, JOHN F. KENNEDY PLAYED A CENTRAL ROLE IN MANAGING THE CRISIS. HIS ADMINISTRATION WAS RESPONSIBLE FOR RESPONDING TO THE MISSILE THREAT, BALANCING MILITARY READINESS WITH DIPLOMATIC EFFORTS TO AVOID WAR. KENNEDY'S LEADERSHIP DURING THE CRISIS IS OFTEN NOTED FOR ITS CAREFUL DELIBERATION AND COMMUNICATION.

NIKITA KHRUSHCHEV

THE SOVIET PREMIER NIKITA KHRUSHCHEV AUTHORIZED THE DEPLOYMENT OF MISSILES IN CUBA TO COUNTERBALANCE U.S. MISSILE INSTALLATIONS AND TO PROTECT CUBA FROM INVASION. KHRUSHCHEV'S DECISIONS WERE INFLUENCED BY STRATEGIC CONSIDERATIONS AND THE DESIRE TO ASSERT SOVIET POWER ON THE GLOBAL STAGE.

FIDEL CASTRO

AS THE LEADER OF CUBA, FIDEL CASTRO SUPPORTED THE MISSILE DEPLOYMENT AS A DETERRENT AGAINST U.S. AGGRESSION. CASTRO'S GOVERNMENT PLAYED A CRITICAL ROLE IN HOSTING THE SOVIET MISSILES AND ENGAGING IN THE GEOPOLITICAL CONFLICT THAT DEFINED THE CRISIS.

ROBERT F. KENNEDY AND OTHER ADVISORS

ROBERT F. KENNEDY, THE U.S. ATTORNEY GENERAL AND PRESIDENTIAL ADVISOR, WAS INSTRUMENTAL IN BACK-CHANNEL COMMUNICATIONS AND NEGOTIATIONS WITH THE SOVIET UNION. OTHER KEY ADVISORS, INCLUDING MEMBERS OF THE EXECUTIVE COMMITTEE OF THE NATIONAL SECURITY COUNCIL (EXCOMM), HELPED FORMULATE U.S. RESPONSES.

TIMELINE OF EVENTS DURING THE CRISIS

THE CUBAN MISSILE CRISIS ANSWER KEY OUTLINES THE SEQUENCE OF EVENTS THAT OCCURRED DURING THE TENSE 13-DAY PERIOD IN OCTOBER 1962. THIS TIMELINE PROVIDES CLARITY ON HOW THE CRISIS DEVELOPED AND WAS MANAGED.

1. OCTOBER 14, 1962: U.S. U-2 RECONNAISSANCE FLIGHTS DISCOVER SOVIET MISSILE SITES IN CUBA.
2. OCTOBER 16, 1962: PRESIDENT KENNEDY IS INFORMED OF THE MISSILE INSTALLATIONS; EXCOMM IS FORMED.
3. OCTOBER 22, 1962: KENNEDY PUBLICLY ANNOUNCES THE DISCOVERY AND DECLARES A NAVAL QUARANTINE AROUND CUBA.
4. OCTOBER 24, 1962: SOVIET SHIPS APPROACH THE QUARANTINE LINE BUT DO NOT ATTEMPT TO BREAK IT.
5. OCTOBER 26-27, 1962: SECRET COMMUNICATIONS AND NEGOTIATIONS BETWEEN THE U.S. AND USSR INTENSIFY.
6. OCTOBER 27, 1962: A U-2 PLANE IS SHOT DOWN OVER CUBA; TENSIONS PEAK.
7. OCTOBER 28, 1962: KHRUSHCHEV AGREES TO REMOVE MISSILES IN EXCHANGE FOR A U.S. PLEDGE NOT TO INVADE

STRATEGIES AND MILITARY ACTIONS

THE CUBAN MISSILE CRISIS ANSWER KEY DELVES INTO THE STRATEGIC DECISIONS AND MILITARY MEASURES TAKEN BY BOTH THE UNITED STATES AND THE SOVIET UNION DURING THE CONFRONTATION. THESE STRATEGIES WERE CRITICAL IN PREVENTING ESCALATION TO FULL-SCALE WAR.

U.S. NAVAL BLOCKADE AND QUARANTINE

PRESIDENT KENNEDY CHOSE A NAVAL QUARANTINE RATHER THAN A FULL BLOCKADE OR IMMEDIATE MILITARY STRIKE. THIS MOVE WAS DESIGNED TO PREVENT FURTHER SOVIET SHIPMENTS OF MISSILES TO CUBA WHILE AVOIDING AN ACT OF WAR. THE QUARANTINE INVOLVED U.S. NAVY SHIPS INTERCEPTING SOVIET VESSELS HEADING TO CUBA.

SOVIET MILITARY POSTURING

THE SOVIET UNION INCREASED ITS MILITARY READINESS IN CUBA AND THE WIDER REGION, PREPARING FOR POSSIBLE CONFLICT. HOWEVER, SOVIET LEADERSHIP SOUGHT TO AVOID DIRECT MILITARY ENGAGEMENT, FOCUSING ON DIPLOMATIC MEANS TO RESOLVE THE CRISIS.

DIPLOMATIC NEGOTIATIONS AND BACK-CHANNEL COMMUNICATIONS

THROUGHOUT THE CRISIS, SECRET NEGOTIATIONS BETWEEN THE U.S. AND USSR PLAYED A CRUCIAL ROLE. THESE DISCUSSIONS HELPED BOTH SIDES FIND A FACE-SAVING RESOLUTION THAT INCLUDED THE REMOVAL OF MISSILES AND ASSURANCES REGARDING FUTURE ACTIONS.

RESOLUTION AND AFTERMATH

FOLLOWING THE CRISIS, THE SUPERPOWERS ESTABLISHED DIRECT COMMUNICATION CHANNELS, SUCH AS THE MOSCOW-WASHINGTON HOTLINE, TO PREVENT FUTURE MISUNDERSTANDINGS. THE CRISIS ALSO LED TO INCREASED EFFORTS IN ARMS CONTROL, INCLUDING THE PARTIAL NUCLEAR TEST BAN TREATY OF 1963.

EFFECTS ON CUBA AND LATIN AMERICA

CUBA REMAINED A COMMUNIST STATE UNDER CASTRO'S LEADERSHIP BUT WAS NOW MORE ISOLATED POLITICALLY AND ECONOMICALLY. THE CRISIS ALSO INFLUENCED U.S. POLICY IN LATIN AMERICA, EMPHASIZING CONTAINMENT OF COMMUNISM THROUGH DIPLOMACY AND COVERT OPERATIONS.

SIGNIFICANCE AND LEGACY OF THE CUBAN MISSILE CRISIS
