UNDERSTANDING THE WORLD ECONOMIC FORUM

THE WORLD ECONOMIC FORUM (WEF) IS A PROMINENT INTERNATIONAL ORGANIZATION COMMITTED TO IMPROVING THE STATE OF THE WORLD THROUGH PUBLIC-PRIVATE COOPERATION. THE ORGANIZATION'S INFLUENCE IS REFLECTED IN ITS ABILITY TO SHAPE GLOBAL ECONOMIC POLICIES AND FOSTER MULTI-SECTOR COLLABORATION. AS A SPACE WHERE POLICY IDEAS ARE DEBATED AND NEW FRAMEWORKS ARE DEVELOPED, THE WEF PLAYS A VITAL ROLE IN SETTING AGENDAS THAT AFFECT INTERNATIONAL MARKETS, TRADE, AND GOVERNANCE STRUCTURES.

DAN CRENSHAW'S BACKGROUND AND POLITICAL STANCE
