

FORCED CISSIFICATION

FORCED CISSIFICATION IS A TERM THAT HAS EMERGED WITHIN SOCIOCULTURAL AND GENDER DISCOURSE, OFTEN DESCRIBING THE IMPOSITION OF CISGENDER NORMS AND IDENTITIES UPON INDIVIDUALS WHO DO NOT INHERENTLY IDENTIFY AS CISGENDER.
