VOTER ELIGIBILITY AND REGISTRATION

UNDERSTANDING VOTER ELIGIBILITY AND THE REGISTRATION PROCESS IS FUNDAMENTAL FOR PARTICIPATION IN THE 2022 ELECTIONS IN LARIMER COUNTY. COLORADO LAW REQUIRES THAT VOTERS MEET SPECIFIC CRITERIA TO BE ELIGIBLE TO VOTE IN ANY ELECTION CONDUCTED WITHIN THE COUNTY.

WHO IS ELIGIBLE TO VOTE?

TO BE ELIGIBLE TO VOTE IN LARIMER COUNTY IN 2022, INDIVIDUALS MUST:

- BE A UNITED STATES CITIZEN.
- BE A RESIDENT OF COLORADO AND LARIMER COUNTY.
- BE AT LEAST 18 YEARS OLD ON OR BEFORE ELECTION DAY.
- BE REGISTERED TO VOTE AT THEIR CURRENT ADDRESS.
- NOT BE SERVING A SENTENCE FOR A FELONY CONVICTION (VARIES BY STATE LAW).

HOW TO REGISTER TO VOTE

VOTER REGISTRATION IN LARIMER COUNTY CAN BE COMPLETED THROUGH SEVERAL CONVENIENT METHODS. RESIDENTS ARE ENCOURAGED TO REGISTER AS EARLY AS POSSIBLE TO AVOID ANY LAST-MINUTE ISSUES.

- **ONLINE REGISTRATION:** AVAILABLE THROUGH THE COLORADO SECRETARY OF STATE'S WEBSITE USING A VALID COLORADO DRIVER'S LICENSE OR ID CARD.
- **MAIL REGISTRATION:** FORMS CAN BE OBTAINED FROM THE LARIMER COUNTY CLERK'S OFFICE OR VARIOUS PUBLIC LOCATIONS AND MAILED IN BEFORE THE REGISTRATION DEADLINE.
- **IN-PERSON REGISTRATION:** AVAILABLE AT THE LARIMER COUNTY CLERK'S OFFICE AND SOME PUBLIC FACILITIES, INCLUDING LIBRARIES AND GOVERNMENT OFFICES.

VOTERS MUST REGISTER AT LEAST 22 DAYS BEFORE THE ELECTION TO BE ELIGIBLE TO VOTE IN THAT ELECTION.

VOTING METHODS AVAILABLE IN LARIMER COUNTY

LARIMER COUNTY OFFERS MULTIPLE VOTING OPTIONS TO ACCOMMODATE VOTER PREFERENCES AND ENSURE ACCESSIBILITY. THE 2022 ELECTIONS PROVIDE FLEXIBILITY THROUGH MAIL-IN BALLOTS, IN-PERSON VOTING, AND EARLY VOTING OPTIONS.

MAIL-IN VOTING

COLORADO IS A STATE THAT CONDUCTS ALL ELECTIONS PRIMARILY THROUGH MAIL-IN BALLOTS. REGISTERED VOTERS IN LARIMER COUNTY WILL AUTOMATICALLY RECEIVE THEIR BALLOTS BY MAIL BEFORE THE ELECTION. THIS SYSTEM PROMOTES CONVENIENCE AND SAFETY, ALLOWING VOTERS TO CAST THEIR BALLOTS FROM HOME WITHOUT VISITING A POLLING PLACE.

IN-PERSON VOTING

WHILE MAIL BALLOTS ARE THE STANDARD, VOTERS MAY ALSO CHOOSE TO VOTE IN PERSON AT DESIGNATED POLLING LOCATIONS. THIS INCLUDES EARLY VOTING CENTERS AND VOTE CENTERS ON ELECTION DAY.

EARLY VOTING

EARLY VOTING CENTERS OPEN SEVERAL DAYS BEFORE ELECTION DAY TO ACCOMMODATE VOTERS WHO PREFER TO CAST THEIR BALLOTS IN PERSON BUT WANT TO AVOID THE CROWDS OR SCHEDULING CONFLICTS ON ELECTION DAY.

IMPORTANT DATES AND DEADLINES

KEEPING TRACK OF KEY DATES AND DEADLINES IS CRUCIAL FOR PARTICIPATION IN THE 2022 LARIMER COUNTY ELECTIONS. MISSING A DEADLINE COULD RESULT IN BEING UNABLE TO VOTE OR HAVING YOUR BALLOT REJECTED.

REGISTRATION DEADLINES

THE DEADLINE TO REGISTER TO VOTE FOR THE 2022 ELECTIONS IN LARIMER COUNTY IS TYPICALLY 22 DAYS PRIOR TO ELECTION DAY. THIS MEANS POTENTIAL VOTERS MUST SUBMIT THEIR REGISTRATION BY THE SPECIFIED DATE TO BE ELIGIBLE.

BALLOT MAILING AND RETURN DATES

BALLOTS ARE MAILED TO REGISTERED VOTERS APPROXIMATELY 15 TO 20 DAYS BEFORE ELECTION DAY. VOTERS MUST RETURN THEIR COMPLETED BALLOTS BY 7:00 P.M. ON ELECTION DAY EITHER BY MAIL OR AT DESIGNATED DROP-OFF LOCATIONS.

EARLY VOTING PERIOD

EARLY VOTING IN LARIMER COUNTY USUALLY BEGINS APPROXIMATELY 15 DAYS BEFORE ELECTION DAY AND CONTINUES UP TO THE DAY BEFORE THE ELECTION. SPECIFIC EARLY VOTING DATES AND TIMES ARE ANNOUNCED BY THE COUNTY CLERK'S OFFICE EACH ELECTION CYCLE.

UNDERSTANDING THE 2022 BALLOT

THE 2022 BALLOT IN LARIMER COUNTY INCLUDES A VARIETY OF RACES AND MEASURES AT THE LOCAL, STATE, AND FEDERAL LEVELS. VOTERS SHOULD FAMILIARIZE THEMSELVES WITH THE CANDIDATES AND ISSUES TO MAKE INFORMED DECISIONS.

FEDERAL AND STATE RACES

VOTERS WILL ENCOUNTER RACES FOR U.S. CONGRESS, COLORADO STATE LEGISLATURE, AND OTHER STATE OFFICES. UNDERSTANDING THE CANDIDATES' PLATFORMS AND VOTING RECORDS IS ESSENTIAL FOR RESPONSIBLE PARTICIPATION.

LOCAL ELECTIONS AND MEASURES

LARIMER COUNTY VOTERS WILL ALSO SEE LOCAL GOVERNMENT RACES INCLUDING COUNTY COMMISSIONERS, SCHOOL BOARD MEMBERS, AND CITY OFFICIALS. ADDITIONALLY, BALLOT MEASURES OR PROPOSITIONS ADDRESSING TAX LEVIES, BOND ISSUES, AND POLICY QUESTIONS MAY BE INCLUDED.

HOW TO RESEARCH CANDIDATES AND MEASURES

VOTERS ARE ENCOURAGED TO CONSULT OFFICIAL VOTER GUIDES, ATTEND CANDIDATE FORUMS, AND REVIEW NONPARTISAN RESOURCES TO GAIN AN ACCURATE UNDERSTANDING OF WHAT IS AT STAKE IN THE 2022 ELECTION.

POLLING LOCATIONS AND ACCESSIBILITY

FOR THOSE CHOOSING TO VOTE IN PERSON, LARIMER COUNTY ENSURES MULTIPLE POLLING SITES AND VOTE CENTERS ARE ACCESSIBLE AND AVAILABLE THROUGHOUT THE COMMUNITY.

POLLING PLACE LOCATIONS

POLLING PLACES ARE STRATEGICALLY LOCATED ACROSS LARIMER COUNTY TO SERVE VOTERS CONVENIENTLY. LOCATIONS ARE CONFIRMED AND COMMUNICATED BY THE COUNTY CLERK PRIOR TO EACH ELECTION.

ACCESSIBILITY ACCOMMODATIONS

ALL POLLING LOCATIONS IN LARIMER COUNTY COMPLY WITH THE AMERICANS WITH DISABILITIES ACT (ADA) STANDARDS, PROVIDING ACCESSIBLE VOTING MACHINES AND ASSISTANCE FOR VOTERS WITH DISABILITIES. LANGUAGE ASSISTANCE AND OTHER ACCOMMODATIONS ARE ALSO AVAILABLE UPON REQUEST.

WHAT TO BRING TO THE POLLS

VOTERS ARE ADVISED TO BRING A VALID FORM OF IDENTIFICATION, SUCH AS A COLORADO DRIVER'S LICENSE OR STATE-ISSUED

ID, AND THEIR VOTER NOTIFICATION CARD IF AVAILABLE. POLL WORKERS ARE TRAINED TO ASSIST VOTERS WHO MAY HAVE LOST OR FORGOTTEN THEIR ID.

ADDITIONAL RESOURCES FOR VOTERS

LARIMER COUNTY PROVIDES VARIOUS RESOURCES TO ASSIST VOTERS IN PREPARING FOR THE 2022 ELECTION AND ENSURING THEIR VOTES COUNT.

COUNTY CLERK AND ELECTION OFFICE

THE LARIMER COUNTY CLERK AND RECORDER'S OFFICE IS THE PRIMARY RESOURCE FOR VOTER REGISTRATION, BALLOT QUESTIONS, POLLING LOCATIONS, AND ELECTION RESULTS. THEY PROVIDE UP-TO-DATE INFORMATION AND ASSISTANCE THROUGHOUT THE ELECTION CYCLE.

VOTER EDUCATION MATERIALS

OFFICIAL VOTER GUIDES, SAMPLE BALLOTS, AND FREQUENTLY ASKED QUESTIONS ARE TYPICALLY DISTRIBUTED THROUGH MAILINGS AND ONLINE PORTALS TO HELP VOTERS UNDERSTAND THE ELECTION PROCESS AND CONTENT.

CONTACT AND SUPPORT SERVICES

FOR QUESTIONS OR CONCERNS, VOTERS CAN CONTACT THE COUNTY'S ELECTION OFFICE VIA PHONE OR EMAIL. SUPPORT IS AVAILABLE TO HELP RESOLVE ISSUES SUCH AS REGISTRATION STATUS, BALLOT TRACKING, AND VOTING PROCEDURES.
