OVERVIEW OF THE LS CMI TOOL

THE LS CMI, OR LEVEL OF SERVICE/CASE MANAGEMENT INVENTORY, IS A WIDELY RECOGNIZED RISK ASSESSMENT AND CASE MANAGEMENT TOOL USED IN CRIMINAL JUSTICE SETTINGS. IT IS DESIGNED TO EVALUATE AN OFFENDER'S RISK OF RECIDIVISM AND IDENTIFY KEY CRIMINOGENIC NEEDS THAT SHOULD BE ADDRESSED DURING SUPERVISION. THE LS CMI SCORING GUIDE PROVIDES DETAILED INSTRUCTIONS ON HOW TO ADMINISTER THE INSTRUMENT AND SCORE RESPONSES ACCURATELY. THIS TOOL SUPPORTS EVIDENCE-BASED PRACTICES BY GUIDING PROFESSIONALS IN TAILORING INTERVENTIONS TO REDUCE REOFFENDING RISK.

PURPOSE AND DEVELOPMENT

THE LS CMI WAS DEVELOPED TO COMBINE RISK ASSESSMENT AND CASE MANAGEMENT PLANNING INTO ONE COMPREHENSIVE INSTRUMENT. IT EVALUATES STATIC AND DYNAMIC RISK FACTORS, ULTIMATELY ASSISTING PRACTITIONERS IN MAKING DATA-DRIVEN DECISIONS. THE SCORING GUIDE ENSURES CONSISTENCY AND RELIABILITY IN SCORING, WHICH IS CRITICAL FOR MAINTAINING THE TOOL'S VALIDITY ACROSS DIFFERENT USERS AND SETTINGS.

TARGET POPULATION AND USAGE

THE LS CMI IS PRIMARILY USED WITH ADULT OFFENDERS WITHIN PROBATION, PAROLE, AND CORRECTIONAL PROGRAMS. ITS APPLICATION EXTENDS TO BOTH PRE-SENTENCE INVESTIGATIONS AND ONGOING SUPERVISION. THE SCORING GUIDE HELPS USERS DETERMINE THE LEVEL OF SUPERVISION AND INTERVENTION NEEDED BASED ON INDIVIDUAL RISK AND NEED PROFILES.

KEY COMPONENTS OF THE LS CMI SCORING GUIDE

THE LS CMI SCORING GUIDE BREAKS DOWN THE ASSESSMENT INTO MULTIPLE DOMAINS, EACH REPRESENTING CRITICAL AREAS OF AN OFFENDER'S LIFE THAT IMPACT THEIR RISK LEVEL. UNDERSTANDING THESE COMPONENTS IS FUNDAMENTAL TO ACCURATELY SCORING AND INTERPRETING THE LS CMI.

DOMAIN STRUCTURE

THE LS CMI EVALUATES EIGHT PRIMARY DOMAINS, EACH CONTRIBUTING TO THE OVERALL RISK AND NEED SCORE:

- CRIMINAL HISTORY
- EDUCATION AND EMPLOYMENT
- FAMILY AND MARITAL RELATIONSHIPS
- LEISURE AND RECREATION
- COMPANIONS
- ALCOHOL AND DRUG PROBLEMS
- PROCRIMINAL ATTITUDE AND ORIENTATION
- ANTISOCIAL PATTERN

EACH DOMAIN CONTAINS MULTIPLE ITEMS THAT ARE SCORED ACCORDING TO SPECIFIC CRITERIA OUTLINED IN THE SCORING GUIDE. THE AGGREGATION OF SCORES ACROSS THESE DOMAINS PROVIDES A COMPREHENSIVE RISK PROFILE.

SCORING METHODOLOGY

THE SCORING GUIDE SPECIFIES HOW TO ASSIGN POINTS BASED ON THE OFFENDER'S RESPONSES AND CASE FILE INFORMATION. SCORES TYPICALLY REFLECT THE PRESENCE OR ABSENCE OF RISK FACTORS, WITH SOME ITEMS WEIGHTED DIFFERENTLY DEPENDING ON THEIR PREDICTIVE VALIDITY. THE TOTAL SCORE IS THEN USED TO CATEGORIZE OFFENDERS INTO RISK LEVELS SUCH AS LOW, MODERATE, OR HIGH RISK.

INTERPRETING LS CMI SCORES

PROPER INTERPRETATION OF LS CMI SCORES IS VITAL FOR EFFECTIVE CASE MANAGEMENT AND RESOURCE ALLOCATION. THE SCORING GUIDE OFFERS DETAILED DESCRIPTIONS OF RISK CATEGORIES AND CORRESPONDING MANAGEMENT RECOMMENDATIONS.

RISK LEVEL CLASSIFICATION

BASED ON TOTAL SCORES, OFFENDERS ARE CLASSIFIED INTO DISTINCT RISK LEVELS:

- **Low Risk:** INDICATES MINIMAL LIKELIHOOD OF REOFFENDING AND TYPICALLY REQUIRES LESS INTENSIVE SUPERVISION.
- **Moderate Risk:** SUGGESTS A MODERATE CHANCE OF RECIDIVISM, WARRANTING TARGETED INTERVENTIONS FOCUSED ON IDENTIFIED NEEDS.
- **High Risk:** REFLECTS A SIGNIFICANT PROBABILITY OF REOFFENDING, NECESSITATING INTENSIVE SUPERVISION AND COMPREHENSIVE INTERVENTION STRATEGIES.

CRIMINOGENIC NEEDS AND RESPONSIVITY

BEYOND RISK LEVEL, THE LS CMI SCORING GUIDE EMPHASIZES THE IDENTIFICATION OF CRIMINOGENIC NEEDS—DYNAMIC FACTORS

THAT CAN BE CHANGED THROUGH INTERVENTION. THESE NEEDS GUIDE THE DEVELOPMENT OF INDIVIDUALIZED CASE PLANS. RESPONSIVITY PRINCIPLES, WHICH CONSIDER HOW OFFENDERS BEST RESPOND TO TREATMENT, ARE ALSO INTEGRATED INTO SCORE INTERPRETATION.

APPLICATION OF LS CMI SCORES IN CASE MANAGEMENT

THE LS CMI SCORING GUIDE IS NOT ONLY A MEASUREMENT TOOL BUT ALSO A FRAMEWORK FOR ENHANCING CASE MANAGEMENT PRACTICES. SCORES INFORM SUPERVISION LEVELS, TREATMENT REFERRALS, AND PROGRESS MONITORING.

WHAT IS THE LS CMI SCORING GUIDE USED FOR?

THE LS CMI (LEVEL OF SERVICE CASE MANAGEMENT INVENTORY) SCORING GUIDE IS USED TO ASSESS THE RISK AND NEEDS OF OFFENDERS IN CRIMINAL JUSTICE SETTINGS, HELPING TO INFORM CASE MANAGEMENT AND REHABILITATION PLANS.

HOW ARE SCORES INTERPRETED IN THE LS CMI SCORING GUIDE?

THE LS CMI IS PRIMARILY DESIGNED FOR ADULT OFFENDERS; HOWEVER, THERE ARE ADAPTED VERSIONS LIKE THE YLS/CMI SPECIFICALLY TAILORED FOR JUVENILE POPULATIONS.

HOW OFTEN SHOULD THE LS CMI BE ADMINISTERED AND SCORED?

THE LS CMI IS TYPICALLY ADMINISTERED AT INTAKE AND REASSESSED PERIODICALLY DURING SUPERVISION TO MONITOR CHANGES IN RISK AND NEEDS, USUALLY EVERY 6 TO 12 MONTHS OR AS CASE CIRCUMSTANCES CHANGE.
