THIS DYNAMIC TRANSFORMS SIMPLE WIN-LOSS OUTCOMES INTO A MORE COMPLEX BETTING ENVIRONMENT WHERE UNDERDOGS CAN "WIN" FOR BETTORS DESPITE NOT WINNING THE ACTUAL GAME.

DEFINITION OF THE POINT SPREAD

THE POINT SPREAD IS A NUMERICAL VALUE ASSIGNED TO BALANCE PERCEIVED DISPARITIES BETWEEN TWO COMPETING NFL TEAMS. FOR EXAMPLE, IF THE NEW ENGLAND PATRIOTS ARE FAVORED BY 7 POINTS AGAINST THE UNDERDOG MIAMI DOLPHINS, THE DOLPHINS MUST EITHER WIN THE GAME OR LOSE BY FEWER THAN 7 POINTS FOR AN ATS BET ON THEM TO SUCCEED. THIS MECHANISM ENCOURAGES BETTING ACTION ON BOTH SIDES AND MAKES NFL GAMES MORE ENGAGING FROM A WAGERING PERSPECTIVE.

ROLE OF UNDERDOGS IN NFL BETTING MARKETS

UNDERDOGS PLAY A CRITICAL ROLE IN NFL BETTING MARKETS BY REPRESENTING OPPORTUNITIES FOR HIGHER PAYOUTS AND CHALLENGING CONVENTIONAL EXPECTATIONS. FACTORS INFLUENCING UNDERDOG PERFORMANCE AGAINST THE SPREAD
