- FACE SWAP-GAN: UTILIZES GENERATIVE ADVERSARIAL NETWORKS FOR IMPROVED REALISM.

IMPACT ON CELEBRITIES AND SOCIETY

LEGAL FRAMEWORK AND ENFORCEMENT
