I HEREBY SWEAR THAT THE STATEMENTS MADE ABOVE ARE TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE AND BELIEF, AND I UNDERSTAND THAT ANY FALSE STATEMENT MAY SUBJECT ME TO PENALTIES UNDER THE LAW.

NOTARY PUBLIC

LEGAL IMPORTANCE AND USES OF AN AFFIDAVIT OF LOSS
