UNDERSTANDING THE CONCEPT OF STATE AND FEDERAL POWERS

FEDERAL POWERS

FEDERAL POWERS REFER TO THE SPECIFIC RESPONSIBILITIES AND AUTHORITIES GRANTED TO THE NATIONAL GOVERNMENT. STATE POWERS
