UNDERSTANDING THE UNITED STATES CONSTITUTION

THE UNITED STATES CONSTITUTION IS THE SUPREME LAW OF THE UNITED STATES, OUTLINING THE NATIONAL FRAMEWORK OF GOVERNMENT, FUNDAMENTAL RIGHTS, AND GUIDING PRINCIPLES. BILL OF RIGHTS AND AMENDMENTS

EXPLORATION OF THE FIRST TEN AMENDMENTS AND SUBSEQUENT SIGNIFICANT AMENDMENTS ALLOWS PARTICIPANTS TO APPRECIATE THE PROTECTIONS AFFORDED TO CITIZENS. THIS SECTION OFTEN INCLUDES TASKS RELATED TO FREEDOMS OF SPEECH, RELIGION, DUE PROCESS, AND VOTING RIGHTS.

AMENDMENT PROCESS

THE CONSTITUTION'S FLEXIBILITY IS DEMONSTRATED THROUGH ITS AMENDMENT PROCEDURES. THE SCAVENGER HUNT ENCOURAGES LEARNERS TO DISCOVER HOW AMENDMENTS ARE PROPOSED AND RATIFIED, FOSTERING AN UNDERSTANDING OF CONSTITUTIONAL EVOLUTION.

INCORPORATING PRIMARY AND SECONDARY SOURCES
