HISTORICAL BACKGROUND OF WITCHCRAFT IN SALEM

THE HYSTERIA WAS FUELED BY A COMBINATION OF RELIGIOUS BELIEFS, LOCAL RIVALRIES, ECONOMIC PRESSURES, AND PSYCHOLOGICAL STRESS WITHIN THE COMMUNITY. UNDERSTANDING THIS HISTORICAL BACKGROUND IS ESSENTIAL FOR GRASPING THE COMPLEXITIES PRESENTED IN COMMONLIT'S EDUCATIONAL MATERIALS ON THE TOPIC.

LEGAL PROCEEDINGS AND OUTCOMES

THE SALEM WITCH TRIALS WERE MARKED BY A SERIES OF HEARINGS AND COURT CASES THAT RELIED HEAVILY ON SPECTRAL EVIDENCE, OR TESTIMONY ABOUT DREAMS AND VISIONS. THIS FORM OF EVIDENCE WAS CONTROVERSIAL AND EVENTUALLY DISCREDITED, BUT IT PLAYED A CRUCIAL ROLE DURING THE TRIALS.
